PERMIT IMPRINTS/INDICIA

Unless printed directly on an address label, the indicia content must be placed within a clear area no smaller than .5" high and .5" wide, no more than 1.5" below or left from the upper right corner of the mailpiece or of the address area when oriented to read the address, regardless of processing category or postage rate claimed. If printed on an address label (including paper, adhesive, and multilayer sandwich labels), the space allowed for the indicia content must be rectangular, large enough to ensure legibility of that content from a normal reading distance and to separate it from other information on the label, and located in the upper right corner of the label when oriented to read the address.
